### **DEVELOPMENT FEES** (determined by Council at time of application)

#### **Subdivision of Land for Development:**

- Town of Paradise Policy is that ALL new subdivision development be carried out at no cost to the Town, including the installation of any required infrastructure.
- All planning, engineering, and legal cost incurred by the Town are the responsibility of the developer.
- Land for public purposes is to be provided at a rate of 10% of the area of the land to be developed or, at Council's discretion, cash in lieu of land at 10% of the value of the land at time of subdivision. Park Outfitting fees must be paid at the rate of \$500.00 per lot. (Does not apply to homestead lot)
- A development agreement may be necessary and appropriate financial security will be required.
- Developers may be required to prepare/upgrade those open space areas that are to be conveyed to the Town. Details of open space preparation and upgrading shall be outlined in the written agreement between the Developer and Council
